**Objectives:** On the third day of class for the upcoming school year, students will complete a quiz in which reading and understanding of chapters 2 and 3 of *The American Pageant* (12<sup>th</sup> edition) textbook will be demonstrated. The summer assignment is to prepare for this college-level quiz. This quiz will NOT be open-note, but students should take notes and organize the text to aid them in understanding the content. On the quiz, students will be asked questions about important historical figures, events, and concepts in chapters 2 and 3. They will also be asked to compare and contrast (similarities and differences) the various settlements of colonial America. Students should be prepared to answer quiz questions with historical detail; a general understanding of the content will not be enough to score well on the quiz.
